Call to Order – Laurie Findlay, President - 7:04 PM

Secretary Report – presented by Lisa Beatty

- The Board reviewed the January 14, 2014 meeting minutes. It was agreed by all Board members that the minutes were accurate as written.
- Karen Kelly made a motion to approve the minutes of the meeting, seconded by Karen Ball, and unanimously approved by all.
- New Correspondence there was none to discuss.

Treasurer Report – presented by Karen Kelly

- Financial Report Karen Kelley presented and discussed the CALPACA operating budget indicating the 2014 proposed budget with year to date expenses, and the 2013 budget for comparison.

Phyl will email all the sponsors about their ad. Phyl additionally indicated that the next Connection issue is the one to advertise in since it also contains the membership directory.
