  - Gold Country Gathering 2014 Karen Ball
    - Judges are confirmed for the show, and the event is listed on Grass Valley Fairgrounds event calendar. Sue lves is working on spin-off forms and a spin-off judge has also been confirmed. Planning to go live on the online registration for spin-off by the end of the week. As soon as the spin-off forms have been updated, a series of email blasts for spin-off will be spent. for closing the fleece show will start emails for that as well.

  - o 2014 Fiber Event Update Phyl Clempson
    - Has not been able to have a conversation with Dale re: a date and focus for a fiber event. Phyl will follow up with Dale and update the Board at the next board meeting.
- New Business
  - Lambtown Booth The membership was not in favor of doing a sponsorship for Lambtown, but they were in favor of having a booth. Lambtown is the 4<sup>th</sup> and 5<sup>th</sup> of October. The question is who would staff the booth throught the weekend? The Board would need to ask for volunteers to represent Calpaca, not their farms. Will need to be an informational booth. Laurie will find out the cost of a booth and will update the BOD.
  - AOA Leadership Council Laurie updated the Board that when you are president of an affiliate, AOA invites you to join the Leadership Council.
