Minutes of BOD Meeting June 8, 2015 Approved by Karen Ball, Sandra Wallace, and Steve Aitchison.

Membership Update: 2 new members in June. 103 members total for 2105 year, 16 of which are new members.

Not clear whether we are ahead or behind last year in memberships—depending on whether the money earned from memberships was tallied thru Dec. 31, or for the current year (membership renewals for the next year begin in October.

KB suggested we develop an incentive to encourage early renewal. A raffle for a free registration to the Symposium in January, 2016 for all membership renewals by Dec. 31 was moved by SW. Unanimously approved. Board members excluded from incentive. We will give a free Tshirt to every new Calpaca member for 2015 and 2016—moved by SW. Unanimously approved.

Treasurer's Report Recent update by KB. There are some questions about the endowment. BOD is fairly firm on capping endowment donations at \$50K, which should make it self-supporting.

Update on West Coast Alpaca Show Fleece show registration opens in one week. Website about to be completed. Ad will go in California Connection Fall edition. We will ask affiliates to co-operate in publicizing the show. We would like to start promoting the show.

BOD voted unanimously for KB to send response letter to AOA. *AOA had contacted Karen Ball with concerns that we were collaborating on a show that is not AOA sanctioned.*

AOA Fleece Competition Update KB thought it was a fabulous and uplifting event, with an emphasis on a true co-operative effort to promote alpaca end product. Excellent presentation by a designer, who had experienced problems accessing alpaca fiber. ACOA presentation was also informative.

Update on Election/Nominating Committee—Lisa Beatty encouraged getting an early start on this next year. Ballots go out by October 1 (much more than the required 4 weeks prior to annual meeting). The annual meeting is the 3rd week of November. 4 candidates: Charlene Schmid, Glen Waddell, Donna Morris*, Karen Ball. Nominating Committee is Deb Galway, Laurie Findlay, and Jan Davis.

Hope to get all the statements and photos by July 31 to put it in the <u>Connection</u>. A number of potential candidates were unable to make the commitment to run for office.

Update on Calpaca Connection: Do we have a hard copy herdsire issue this fall? Perhaps we should hold off and do a more thorough and comprehensive issue in the spring. Some of the less technically inclined members may prefer a hard copy, but it's a very expensive undertaking. We would like to attach a directory to the herdsire issue of the Connection. We should send out an eblast each fall when the directory is updated, advising members to print it up from the website for their own personal use and for others who are not on-line.
