

## NAIS - National Animal ID System

### NAIS in a nutshell:

- Each location with livestock must have a Premises ID, i.e. farms, fairgrounds, show venues, etc. These are stored in a central database.
- Each animal must have a permanent ID (microchip, eartag), which will be stored in a central database.
- Movement of animals from one Premises to another must be reported within 24 hours of the movement, with not-yet-determined penalties for failure to report.

Purpose: Be able to trace-back within 48 hours of detection of a serious contagious disease and find all animals that an infected animal has been in contact with.

Details are still being worked out, but those are the basics.

Benchmarks, from April 2006 report "Strategies for Implementation of NAIS"

Jan 2007	25% of premises registered
Jan 2008	70% of premises registered 40% of animals identified
Jan 2009	100% of premises registered 100% of "new" animals identified 60% of animals <1 year of age have complete movement data
