Miss Rost asked if Mr. Smoker will stay on as Treasurer until the January meeting.

Jubilee:

Dr. Bert mentioned that the Board needs to look at show expenses.

Miss Rost mentioned that the Empire show had an increase in entries. Empires offer was if you join Empire and purchased two stalls you got the third stall free.

Dr. Bert mentioned that there are few areas where expenses can be cut.

Dr. Bert mentioned that MAPACA should look into having 500 show mats done with the MAPACA logo to be used in the stalls in place of sod.

Jubilee Sponsorships:

Dr. Bert asked if we should keep the prices the same but add some more benefits to each level.

Mr. Reachard mentioned that he and Supervisor Patty Fuller were working on some up-dated sponsorships and levels for the fleece show.

Mr. Reachard will forward the finished report to the Board for discussion and approval.

Dr. Bert asked the Board to think of ways to thank the Donors from the 2014 live alpaca auction. Dr. Bert suggested offering them a free entry in to the 2015 Auction.

Miss Bittner mentioned that we would need a minimal number of paid auction entries before we offered any free entries.

Miss Lovelidge mentioned the CABO sponsorships and how extensive they are.

Miss Rost mention allowing dual sponsorships.

Miss Kremer mentioned that dual sponsorships would require more signage.

Dr. Bert mentioned that Margie Ault from AOA is willing to meet with the Board to discuss different avenues to be added to the Jubilee.

**Auction:**

D. Bert spoke with Silver Penn Sales. They are interested in hosting the Auction.

Dr. Bert mentioned have 60 lots in the auction.

Dr. Bert mentioned that Silver Penn Sales can have the auction information up on their website by November 15<sup>th</sup>.
