Openherd/VAOBA Email

-Joe & Jan from Openherd have been made aware of the VAOBA situation in regards to Mary Forte, Jay Fentner & their current status as members not in good standing with VAOBA, as well as past issues with the BoD & the issuance of certified letters of acknowledgement of Mary's removal from the VAOBA BoD last fall

-Joe has asked for written/hard copy of the minutes from Dec, as well as other information, as

they are "in the middle here" of the matter. He asked for the current list of officers, minutes from December's meeting, and asked this sent certified mail to him at Openherd. - -Cheri spoke with Marlene in regards to the matter of the cancelled show & what may be owed them
 - -Marlene has stated they will not sue us but will not put this in writing
- -VAOBA has no immediate plans to return to the Fred Expo in the near future due to past matters & cost of the rental of the venue vs VAOBA funds at this time
- -All agreed that the Fred Expo is a fantastic site to have a show, but for VAOBA's current needs, a smaller, less expensive place will be suitable, & given the on-going issues of Covid/cancelled shows
- -As of now, January 2022, VAOBA has no further obligations to the Fred Expo for future shows

Carpet

-Issue of what to do with the carpet in storage in Aylet came up once again
-Marlene at the Fred Expo said they will take the carpet but will not purchase (if we offered it to them)

-Storage unit has been paid thru Feb (thank you Glen!)

-Donna H offered \$5000.00 for the whole lot

-Michelle made a motion to sell the carpet in the storage unit to Donna H for \$5000.00 to settle the matter once & for all, Judy H seconded

-Carpet sold/matter closed
