1.0 Meeting Opening:

2.0 Business:

2.1 Meeting Minutes.

2.1.1 All meeting minutes with exception of Special Meetings of July 28, 29, 31 were approved in July 31 meeting. Special Meeting Minutes will be distributed for approval at next meeting.

2.2 Treasurer Report.

2.2.1 July treasurer's report was provided prior to the meeting. There were no comments.

2.3 Membership Report.

2.3.1 46 members. One joined today.

2.4 Education Report.

- **2.4.1** Dave Grembi requested that we set up online registration for the September 7 seminar. Mary will call Openherd to see if they can assist.
- **2.4.2** We know there are 6 people committed so far. Word of mouth is important. If Directors can share to their personal Facebook page, it would be helpful.
- **2.4.3** Discussed with Donna Higgason if she knows how to do add a PayPal button for seminar registration. She suggested going to Jan at Openherd. Patricia will find out code from PayPal.
- **2.4.4** We should include the PayPal surcharge so that the fee is paid by the person who makes the purchase.

2.5 Secretary Report.

- **2.5.1** VAOBA insurance info was sent to everyone earlier today. Steve Purdy requested that we provide a more permanent contact.

2.6 Show Committee.

- **2.6.1** Mary asked about the Show Budget. The budget includes all estimated expenses for travel. (Donna has last year's expenses.)
- **2.6.2** Carpet for youth ring is \$700 \$1100, depending on which color.
- **2.6.3** We need a volunteer coordinator. No one on the Show Committee has volunteered. We need ring stewards.
- **2.6.4** Will someone on the show committee have access to a credit card for hotel, tape, and other items that need to be purchased?
- **2.6.5** Judy can get 10% off with military discount. There was a request for Judy to have a credit card.
- **2.6.6** The show needs to rent the portable system for the judges (\$180). The announcer will use the whole arena system.
- **2.6.7** Piped in music or audio over PA will be \$50 extra for the weekend.
- **2.6.8** The contract doesn't include the classrooms. There's a big lobby, and two minilobbies. We will use one minilobby for the fleece room. The alpaca 101 loop video can be in other minilobby.
- **2.6.9** Sold sponsorships: one benefactor, 2 platinum, 2 gold, 2 silver. Foster's Trail purchased a platinum at MAPACA auction.
- **2.6.10** There are no vendors yet. However, several have said they have intent.
- **2.6.11** Brett and Debbie can't do herdsire auction. Show Committee has talked to Randy Coleman and he's not sure yet.
- **2.6.12** Mike asked about audio and whether the show can be recorded. It's often difficult to hear what the judges have to say. Show Committee to ask Kevin O'Leary.
- **2.6.13** Donna mentioned that there have been shows in the past where a live video feed and monitors showing close up of what the judge is seeing and commenting on.
- **2.6.14** Show Committee looking for tractor company, fencing company, and others as sponsors and display.
- **2.6.15** We can have food as long as the food vendor doesn't sell same things as venue. Honey, jam, kettle corn, etc.

- **2.7.1** The Show Committee put forward a budget that was sent to Board members in advance of this meeting and Donna provided opportunity for questions and comment.
- **2.7.2** Gail made a motion to accept the show budget as submitted (attached). Brenda seconded the motion. All approved. None opposed.

An email vote was sent to the voting members on August 1, 2019 and approved retaining Kevin Oleary as the event manage. Yes vote: Mary, Glen, Donna, Judy, Elaine, Chanel and Mike.

An email vote was sent to the voting members on August 3, 2019 and approved with a few changes. The sponsor fees are now posted on the website. Yes vote: Mary, Glen, Donna, Judy, Elaine and Chanel. Mike did not vote.

A show committee meeting was held on Monday, August 5, 2019 teleconference. On the call: Donna Higgason, Elaine Simpson, Sue Ives, Cheri Seiler, Chanel Hammer, Glen Kirby, Judy Howe, Patty Fuller and Kevin Oleary. Absent from the Call: Mary Forte and Mike Engle.

The meeting was called to order at 7:37 pm. Donna relayed to the show committee that all contracts are signed and in place for all of the judges, Kevin Oleary and show superintendents. The budget was reviewed by all on the committee call with questions regarding labor, plastic, carpet, ribbons, etc. A motion was made by Elaine Simpson to approve the budge, the motion was seconded by Judy Howe and all voted in favor. Kevin Oleary explained the two show system and the capped number of animals for each show would be approximately 320, doubting we would get that many. Glen Kirby is measuring the building this week and will provide Kevin with the dimensions especially between the poles. Kevin stated that the advertisement is confusing, two for one price as some people think that that includes the halter fees. Kevin contacted Jared at Selle to see if the ad can be re-written detailing that is stalls only and hotels, etc. Kevin suggest we change the color from black to something brighter to get attention.

Sponsorships were discussed. Glen stated we need a list of who the letters went to from the previous committee about sponsorship. Donna stated she would try to get that from Mike. Vendor fees were discussed. The herdsire auction was discussed with a letter sent to Silver Penn Sales, Debbie and Brett to do the auction. Auction requirements that each herdsire either needs to have won a championship or have championship offspring. Kevin will try to get some herdsires. There will be no upfront fees or splitting of the fees with the farm donating the breeding. The herdsires will be online a week prior to the show with Openherd. There are talks of a pen sale at the show with commission to VAOBA and a percentage of the sale. This has been tabled until the next meeting. The Youth subcommittee: Elaine, Chanel, Melissa, Bonnie and Heidi will meet to discuss youth stalls, events, times, fun classes, etc. Donna asked if anyone wanted to be a volunteer coordinator. No one wants to so all will try to find people to help.

The meeting was adjourned at 8:45 pm.
