 - **2.5.7..1.** VAOBA trailer is 12' and packed with show stuff; it won't fit. VAOBA would need at least 16' trailer.
 - **2.5.7..2.** Storage facility will be \$1200 \$1500/yr with difficulty of lifting on and off trailer at both ends.
 - **2.5.7..3.** A cargo trailer would be less expensive. Inspection and weight. Need to know what we'd be looking for.
 - **2.5.7..4.** Will use Judy's landscape trailer if necessary.
 - **2.5.7..5.** Possibly purchase shed that can be delivered to someone's farm to store carpet for minimum 3 years.
 - **2.5.7..6.** Mary asked Donna, Michelle and Judy to work on solution that's best for VAOBA.
- **2.5.8** No VAOBA store this year. No volunteers to work the store.
- **2.5.9** If someone is selling from their stall, they need to pay for vendor license.
- **2.5.10** 63 people signed up for dinner and auction. Backyard BBQ and Auction moved to Saturday evening.
- **2.5.11** Silent auction has quite a few items.
- **2.5.12** Pen sale at 23 entries. Suggests charging more next year.
- **2.5.13** Walking Fleece is sold out and has a waiting list.
- **2.5.14** Gail will work color check.
- **2.5.15** Judy has microchip reader.
